### **Eligibility for Nomination:**

- **President and Vice President:** Any Life or Patron Member who has completed two complete years of membership & has been an Office Bearer of the Unit for at least one full term of two years and fulfil other requirements as per Memorandum & Rules and Regulations of The Textile Association (India) - Delhi would be eligible for the nomination for the Position of President or Position of Vice President.
- **Managing Committee Member:** Any Life or Patron Member who have completed one complete year of membership and fulfil other requirements as per Memorandum & Rules and Regulations of The Textile Association (India) - Delhi would be eligible for the nomination for the position of Managing Committee Member.
- **Governing Council Member:** Any Life or Patron Member who had been the member of Unit's Managing Committee for at least one full term of two years and fulfil other requirements as per Memorandum & Rules and Regulations of The Textile Association (India) - Delhi would be eligible for the nomination for the position of Governing Council Member.
